NEW HIGH COMMISSIONER

The Government of Singapore has appointed Mr Koh Yong Guan as the Singapore High Commissioner to Canada. He will be resident in Singapore. Mr Koh will officially assume the appointment on 21 May 08 after presenting his letter of credentials in Ottawa.

Mr Koh is currently the Chairman of Central Provident Fund Board. He served in the Ministries of Finance (Revenue Division), Education and Defence before being appointed Second Permanent Secretary in the Ministry of Defence in 1989. Mr Koh was the Commissioner of Inland Revenue from 1991 to 1997. In 1998, he was appointed Managing Director, Monetary Authority of Singapore. Mr Koh had also held the appointments of Permanent Secretary in the Ministries of Health and National Development, as well as Second Permanent Secretary in the Ministry of Finance (Budget and Revenue) between 1998 and 2001.

We wish to thank Mr Vanu Gopala Menon, the current High Commissioner for his guidance, friendship and support of Vancouver Singapore Club. Mr Vanu Gopala Menon continues to be the Permanent Representative of Singapore to the United Nations.

News from Singapore..

SINGAPORE – KUALA LUMPUR SHUTTLE SERVICE WILL CEASE ON 1 JUNE 2008

The next time you wish to take a flight from Singapore to Kuala, you will have to book your ticket just like you would do to travel to other destinations.

From 1 June 2008, you will no longer be able to walk in, purchase the ticket and queue for your flight. SIA and MAS have announced that they would be terminating the 25-year Shuttle Agreement.

NEW CHINESE VISA RULES

CHINA has introduced new visa rules on travellers to China ahead of the 2008 Beijing Olympic Games. Changes include new visa requirements, more documents needed for visa applications, and restrictions on movement of foreigners between Hong Kong and China.

These steps are said to be in line with growing security concerns over the August Beijing Olympics and the unrest in Tibet.

'From July 1, 2008, China temporarily requires Singaporean passport holders to enter China with a valid visa,' said the website of the Chinese Embassy in the United States.

The visa-free facility was accorded to Singapore Citizens since 2003 for travels of 15 days or less would be reinstated after the Beijing Olympics. The Chinese authorities have not informed the Ministry of Foreign Affairs of the exact date when the visa-free facility will be reinstated.

All travellers to China now also have to present a return ticket, hotel vouchers and a full itinerary for a visa application.

OVERSEAS OR FOREIGN TALENT?

Prime Minister Lee of Singapore expressed his concern over the loss of local talent when he spoke at the 4th London School of Economics Asia Forum in April 2008.

This was the third time Mr Lee expressed his concern since the Cabinet reshuffle on 29 March 2008.

'To do well, a country needs a core of its ablest citizens, those with both the intellectual and social acumen to play leadership roles in the economy, the administration and the political leadership.

'Without that central core to take the country forward, the society cannot perform to its full potential, and the citizens will suffer,' he said.

But, Mr Lee said, Singapore must accept such talent flows as a reality, draw in foreign talent and encourage its citizens who study and work abroad to return home.

What a refreshing change!
