News from Singapore ...

Taking Local or Foreign Currency out of Singapore

FROM 1 November 2007, travellers who take more than \$\$30,000 in local or foreign currency equivalence in or out of Singapore will have to file a declaration.

This rule also applies to those who send and receive money through cargo, post or other means, but electronic transactions are excluded.

The measure, which was approved by Parliament last month, aims to combat terrorism financing and money laundering, the police said in a statement yesterday.

A declaration is made by filling up a form available at all checkpoints, police stations, Singapore visitor centres and Singapore Post branches, and submitting it to the authorities. The forms, which can also be downloaded from the police and Commercial Affairs Department's website, call for information on the type, amount and reasons for moving the money.

Apart from hard cash, the rule also extends to bearer-negotiable instruments such as travellers's cheques, bills of exchange and money orders.

Travellers can bring in and take out as much currency as they want, as long as they make accurate declarations. Those who fail to furnish accurate reports can be fined up to \$50,000, or jailed up to three years, or both, under the amended Corruption, Drug Trafficking and Other Serious Crimes (Confiscation of Benefits) Act. The money can also be seized.

Cooling off the red hot Singapore property market?

With the unprecedented economic boom of Singapore and higher incomes for most Singaporeans, the property market has been skyrocketing over the past 6 months. Prices are near and in some cases exceeded the 1996 highs.

However, speculators are now reconsidering their positions with the announcement made by the Urban Redevelopment Authority on 26 October 2007 that buyers of uncompleted private homes and offices will no longer have the option of using a deferred payment scheme.

In the past, homebuyers could pay as little as 10 per cent of the purchase price upfront, footing the rest only when the property is ready. House hunters are also thinking twice.

All buyers now will have to use the progressive payment scheme where they pay between 5 per cent and 25 per cent of the purchase price every few months.

Property agents agree that removing the scheme will achieve the Government's aim of reining in the speculators. But the agents believe low-budget buyers could also be hit.

Given the positive sentiments of Singaporeans about their economic prospects in the near future, many believe that the move would have a slight initial dampening effect on their decisions.



SINGAPORE AIRLINES A380 TAKES OFF ON HISTORIC FIRST FLIGHT



On 17 October 2007, at the SIA A380 Welcome Event, Prime Minister of Singapore, Lee Hsien Loong congratulated SIA for being the first to operate the Airbus A380, the world's largest commercial airliner. On 25 October 2007, the world's first A380, operated by Singapore Airlines, enters commercial service that day with its first flight, SQ380, from Singapore to Sydney, Australia. The aircraft departed from Sydney to Singapore the following day for the return leg of the flight.
